## MSSU Department of Nursing Philosophy

The faculty of the Missouri Southern State University Department of Nursing believe:

**Person:** The person is an autonomous, unique, and multidimensional being with inherent integrity and values, capable of caring, growing, and learning. A person can be expanded to include the family or community.

**Health and Illness:** A person's health and illness are influenced by emotional and physical factors, socioeconomic situation, geographical setting, culture, and acuity of care.

**Clinical Situation:** Nursing practice is an art and a science that occurs within a clinical situation. Engagement with the client allows the nurse to notice and interpret patterns of health and illness, allowing the nurse to respond with individualized nursing interventions.

**Nursing Education:** General education supports development of the nurse as a global citizen with an appreciation of art, natural sciences, social sciences, and humanities. Baccalaureate nursing education prepares the graduate nurse through theoretical and clinical education in diverse settings and provides the basis for advanced practice.

**Clinical Judgement:** Clinical judgment requires the ability to recognize aspects of a clinical situation, interpret the meaning and respond appropriately.

**Nurse:** The nurse enters the clinical situation with life and educational experiences, which are foundational to clinical judgement and provision of inclusive client care. The nurse's vision of holistic care stems from knowing and recognizing the client's unique patterns of responses within the clinical situation. (Approved by Faculty Council 12/2020)

## **Nursing Curriculum, Program, and Student Learning Outcomes**

The following plan of study provides a logical sequence of courses, which upon completion meets the requirements for the Bachelor of Science Degree with a major in nursing. All core curriculum courses, and nursing support courses are taken in the freshman and sophomore years. Nursing courses are taken in the junior and senior years. Electives may be taken in the suggested order in the plan of study and upon advisement by the assigned nursing advisor. Course syllabi present the course descriptions, objectives, content, assessment methods, and evaluation grid for the attainment of programmatic student learning outcomes.

Students obtaining a Bachelor of Science Degree with a major in nursing meet the degree requirements when 120 credit hours and all required elements as indicated in the plan of study are completed. The primary purpose of the Bachelor of Science Degree in Nursing Program is to develop a graduate who is generally prepared to practice nursing consistent with the program's philosophy. The graduate is capable of assuming the various roles of the professional nurse and is prepared as an advanced beginner, generalist capable of practicing in a variety of clinical situations using the knowledge and skills obtained throughout the educational experience.

The Bachelor of Science Degree Program tracks for pre-licensure and licensed practical nurses builds upon the lower level/ technical nursing education and through the curriculum design produces a professional nurse with definite knowledge and skills. The faculty has identified the graduate's specific knowledge and skills through program outcomes supported by the curriculum. The student learning outcomes express the faculty's intentions of the competencies a nursing student must achieve as they progress through the curriculum.

### **Program Outcomes**

Upon completion of the nursing program, the graduate will be able to:

- deliver quality professional nursing care based upon knowledge and skills obtained throughout the nursing educational experience.
- practice in a variety of clinical situations using reasoning patterns and nursing intuition at the level of an advanced beginner.
- recognize the importance of ongoing, reflective, and independent learning throughout the professional nursing career.

## **Student Learning Outcomes**

The student learning outcomes are those competencies that are attained as the student progresses through the coursework, clinical and lab experiences within the curriculum:

- Demonstrate leadership principles through client-centered care, teamwork, and collaboration.
- Differentiate professional implications (behaviors, standards, regulations) with respect to safe, ethical, quality, and evidence-based care.
- Provide inclusive holistic nursing care to promote health and prevent disease in all populations.
- Demonstrate adaptability by anticipating and responding to client needs to manage care in a variety of clinical situations.
- Apply evidence-based practice in the delivery of quality, client-centered care.
- Integrate a variety of technology and information technology to communicate, manage, and support clinical decision-making.
- Prioritize clinical actions by noticing, interpreting, responding, & reflecting on clinical findings

**\*\*CLINICAL PRECEPTOR\*\*  
DEFINITION**

A clinical preceptor is an agency staff/professional nurse who serves as a role model for Missouri Southern State University (MSSU) nursing students. The clinical preceptor assists nursing students in meeting the Bachelor of Science Degree Program, Nursing-(BSN) course/clinical objectives in cooperation with the MSSU nursing faculty.

**POLICY**

Clinical preceptors will be used to support and enhance learning in clinical site agencies in senior clinical nursing courses. The MSSU nursing faculty recruits and collaborates with clinical preceptors in their interactions with nursing students.

Students enrolled in the MSSU-BSN Program will not receive payment for services or reimbursement for care given for regular clinical site rotations within a clinical course. A nursing student may receive payment for services or reimbursement for care upon acceptance to the clinical partnership program and employment at an agency offering student nurse internship or clinical partnerships. Clinical preceptors will not be responsible for more than two students at any given time during clinical learning experiences. Each student will have a designated nursing faculty assigned during the clinical site experiences involving a clinical preceptor.

Nursing faculty are responsible for the clinical evaluation of the student. The nursing faculty is also responsible to provide the preceptor with a copy of the designated course clinical objectives, clinical schedule, and preceptor handbook.

**QUALIFICATIONS**

1. Current licensure in good standing as a Registered Nurse in the State of Missouri or compact state. The preceptor will have at least one year of experience in the area of clinical specialty in which the preceptor participates in the student clinical learning experience.
2. The preceptor is recommended by the supervisor/nurse manager/charge nurse of the agency where the clinical experiences are scheduled with approval of the course lead/clinical instructor/BSN Coordinator.
3. Core competencies of a clinical preceptor include:
  - a. Ability to communicate well.
  - b. Serves as a resource person and is familiar with resources that are available in the agency and community.
  - c. Provides student with constructive, meaningful feedback aimed at improving practice.
  - d. Self-confident and responsive to faculty and students.
  - e. Follows the American Nurses' Association (ANA) Code of Ethics.

- f. Uses the ANA Standards of Practice and Nursing Practice Act as a basis for nursing care delivery.
  - g. Demonstrates knowledge of teaching and learning principles through client/staff education.
  - h. Models caring behaviors towards clients and students.
4. Registered nurses designated by their agency as “preceptors,” those who have completed a preceptor course, or completion of training by the Missouri Hospital Association Clinical Faculty Academy are preferred.

## **PROCEDURE**

1. Course/clinical faculty initiates contact with the agency and arranges for clinical preceptors.
2. Faculty provides the agency and clinical preceptor with a Preceptor Handbook that contains the following information: MSSU-BSN Program Philosophy/Mission/Vision/Values related to the clinical experience.
3. Faculty provides the clinical preceptor with course clinical objectives, clinical schedule, expectations for student performance and assessment, and expectations for faculty supervision. Directions on assisting the student to meet course/clinical objectives are provided to the clinical preceptor by faculty.
4. Students are provided orientation to the course syllabus, theory and clinical objectives, clinical rotation schedule, clinical agency, agency policies and procedures, and the clinical preceptor policy.
5. Faculty establishes and maintains communication with student and clinical preceptor to discuss student progress and evaluation by course faculty.

Within the Course Systematic Evaluation Plan (CSEP), the course lead/clinical instructor will provide a summary reflecting the precepted experience data which includes but is not limited to clinical learning experiences, strengths, opportunities for improvement, and recommendations/actionable items for future interactions with the clinical preceptor or agency.

6. Course lead/clinical faculty is responsible for the clinical evaluation of the student.
7. Course evaluations will include questions related to the following: the clinical site, preceptor, ability to meet course objectives, student experiences, and faculty.

## **Precepted Clinical Experience Process**

### **Clinical Preceptor Agreement**

The student will be responsible for completing the clinical preceptor agreement form for each precepted clinical experience. This is provided as a paper form by the course lead of clinical courses in the Senior semesters. A copy of this form is also in the preceptor handbook. The completed form will be maintained in the student's permanent file and secure, electronic file. This is a required component of the clinical experience assignment submission and must be submitted into the appropriate submission area. Late submission is permitted as this form is required. Late submission may incur penalties in clinical evaluation by the course/clinical faculty.

### **Preceptor Evaluation of Nursing Student**

Preceptors will be asked with each precepted experience to complete an evaluation of the precepted student. The preceptor will be provided with a QR code or paper evaluation. The preceptor will complete the evaluation based on their observations, perceptions, and student performance assessment. The evaluation will be confidential. Each evaluation will take 2-4 minutes. Each week after the clinical experience, the course lead/clinical faculty will review the preceptor feedback and complete the final evaluations. The course lead/clinical faculty is solely responsible for student evaluation; however, the clinical instructor works with preceptor feedback to inform the decision-making.

### **Nursing Student Evaluation of Preceptor**

Students will be required to complete an evaluation of their preceptor at the end of each precepted experience. The Nursing Student evaluation of the preceptor is completed via a QR code provided by the clinical faculty. The clinical faculty provides this for clinical courses in the senior semesters. This is a required component of the clinical experience assignment submission. Submission of this form is required. Late submission may incur penalties in clinical evaluation by the course/clinical faculty.

### **Student Log of Clinical Hours**

The student will be responsible for completing a log of hours at the end of a clinical experience. The student's log of clinical hours is completed via a QR code provided by the course lead and/or clinical/simulation faculty. The log of hours is to be completed after each clinical experience at the end of the clinical day, which includes on-campus activities (i.e., skills instruction/practice, orientation, debriefing), simulation, and clinical rotations at the assigned clinical facility. This is a required component of the clinical experience assignment submission. Submission of this form is required. Each week after the clinical experience, the clinical instructor will review the log of hours.

At the conclusion of each semester, the nursing student evaluation of the preceptor, preceptor evaluation of the nursing student, and student log for each clinical course shall be archived in the Nursing Department SharePoint site (Systematic Evaluation Plan>Raw Data Reports) by the BSN Coordinator.

Missouri Southern State University (MSSU) Department of Nursing Clinical Partnership Program  
(NCPP)

**Description:**

A collaborative clinical-academic practice partnership designed to facilitate clinical learning, development of clinical judgment, and student transition to the workplace.

**Theoretical Framework:**

The primary objective of clinical education in nursing is to apply classroom and laboratory content to clinical practice and develop clinical judgment. The MSSU Department of Nursing Clinical Partnership Program (NCPP) creates a robust clinical experience for senior students and preceptors. The NCPP is based on the clinical collaborative model, which has been used for many years in healthcare education.

The benefits of the clinical collaborative model include the promotion of real-world teamwork and collaboration, the facilitation of active learning and shared experience, decreased burnout, and increased learner accountability, independence, and productivity (Academy of the American Physical Therapy Association, 2020). The concept of Professional Identity in the Nursing Discipline underscores the need to prepare senior nursing students for the day-to-day reality of caring for patients in the acute care setting.

Maguire, Zambroski, and Cadena (2012) reported that partnership with a preceptor readies the student to face the many challenges of acute care practice and strengthens the relationship between the student and hospital upon graduation.

DiMattio, Hudacek, and Lovecchio (2020) reported that students participating in a collaborative clinical model found access to opportunity, resources, information, and support clinically empowering. Nurses that participated in the partnership reported reinvigoration of their nursing practice through opportunities for reciprocal learning among students, faculty, nurses, and patients. Kim, Park, and Kang (2013) found significant differences in clinical practice capability between nursing students who received teaching time from a preceptor and those who did not. These authors also found that students' nursing practice capability was directly related to teaching time by a preceptor and that the positive effect increased with the duration of teaching by the preceptor.

MSSU Nursing faculty believe that preceptor orientation is key to the success of the NCPP. Faculty also believe that preceptors must be able to contact faculty at any time during the student's scheduled shifts if concerns or issues arise. Preceptor feedback is integral to student learning. To this end, preceptors are included but are not solely responsible for the formative and summative evaluation of the student. Preceptor feedback about the NCPP is also key to program improvement. Thus, preceptors and health system administrators should participate in the overall program evaluation and be invited to participate in research endeavors related to the program.



**Purpose:** The NCPP seeks to:

- build the student's teamwork and collaboration skills in the clinical setting through real-world experience.
- facilitate confidence and optimal performance and productivity of the graduate nurse.
- promote active learning, shared experience, and reflection to support the development of clinical judgment in the graduate nurse.
- promote independent learning and accountability for learning in the graduate nurse.
- decrease burnout in the graduate nurse.

**Plan:**

- Senior students must meet academic and clinical standards established by the MSSU Department of Nursing.
- Students must complete the departmental application process and have recommendations from **two nursing faculty members**.
- Students must prepare and present a resume and provide an updated skills checklist upon application to the MSSU Department of Nursing NCPP. Students are advised that an updated skills checklist booklet is recommended when interviewing for NCPP-affiliated employers.
- Students must apply to the health system following the health system's employment practices.
- Application does not guarantee acceptance to the NCPP.
- Acceptance to the NCPP does not guarantee an offer of employment from the health system.
- **Once the student is accepted to the NCPP, the student will:**
  - work as required by the health system in addition to the required NCPP hours.
  - work the schedule of the assigned preceptor within the constraints of the student's class and clinical schedules.
  - understand that the shift begins with the outgoing shift report and ends with the oncoming shift report.
  - communicate openly with the preceptor, Adult Health IV course lead/clinical instructor, and MSSU BSN coordinator throughout the experience.
  - abide by all policies and procedures of the health system and those outlined in the current MSSU Nursing Student Handbook and Safety and Exposure Manual.
  - Receive credit for the scheduled workday for up to 12 hours per clinical day. Students may work 8, 10, or 12-hour days as the health system requires.

- receive credit for up to 45 hours in the Adult Health IV clinical course (Senior II semester).
  - understand that NCPP hours must be communicated to the Adult Health IV course lead upon scheduling these with the healthcare system. NCPP hours must not conflict with regularly scheduled clinical hours as required in Adult Health IV or Concepts of Population Health Nursing.
  - understand hourly wages from the health system based on experience may be offered.
  - understand that a commitment to employment of up to one-year or longer may be offered and/or required by the health system.
  - evaluate the preceptor and overall experience during the NCPP
  - anticipate conferencing with the rounding clinical faculty as a method of formative and summative evaluation.
- **Once the student is accepted to the NCPP, the course lead/clinical instructor will:**
    - provide face-to-face (or virtual) orientation of the preceptor to faculty contact information and student requirements outlined in the *Preceptor Handbook*.
    - contact the preceptor to discuss student progress and concerns or issues.
    - collaborate with the preceptor in formative and summative evaluation of the student.
- **Once the student is accepted to the NCPP and has secured a position, the health system will:**
    - Assign a preceptor with a minimum of one year of clinical experience to serve as the student's preceptor. The assignment of the preceptor will be based on the student's interests and/or needs of the health system.
    - orient the student to the preceptor's unit as the health system requires.
    - provide the MSSU BSN coordinator with a final list of accepted students and their assigned preceptors.
    - communicate the opening of the application cycle, including the deadline for application each semester.
  - **The student may receive compensation for shifts worked/scheduled with the health system. This is at the discretion of the facility and the NCPP health system.**

- **The student must provide the date/shift schedule to the course lead. Rounding will occur during scheduled shifts by designated faculty/administrative staff. Advance notice will be provided to the student. Students can anticipate conferencing with the rounding clinical faculty as a formative and summative evaluation method.**
- **The program will:**
  - Provide an on-call schedule to the NCPP student, identifying the clinical faculty/BSN Coordinator/Department Chair who is on call and providing contact information. The on-call individual will be available 24 hours a day during the scheduled call time. Any urgent/emergent nature issue should be communicated promptly, including but not limited to issues with staffing, illness/injury, or practice concerns.

- **Once the student is accepted to the NCPP, the preceptor will:**
  - complete the MSSU Department of Nursing preceptor agreement form. This form must be completed should the student be reassigned to a different preceptor. In such cases, this must be communicated to the course lead/clinical faculty immediately.
  - serve as a mentor for the student, facilitating active learning, reflection, and development of clinical judgment.
  - attend a face-to-face (or virtual) orientation to faculty contact information and student requirements outlined in the *Preceptor Handbook*.
  - evaluate the student's performance and provide frequent and meaningful feedback to the student.
  - communicate evaluation of the student's performance to the course lead/clinical faculty, MSSU BSN coordinator and/or department chair.
  - collaborate with MSSU nursing faculty members to complete the final evaluation of the student.

- I understand that I must meet academic and clinical standards set forth by MSSU and have the recommendation of two faculty for this program.
- I understand that I will prepare and present a resume and updated skills checklist during the interview with the health system.
- I understand that application to the NCPP does not guarantee acceptance into the NCPP.
- Please submit all required documents and the application as provided by the QR code no later than **September 30<sup>th</sup> at 11:59 pm.**

- I understand that acceptance into the NCPP does not guarantee an offer of employment from the health system.

**Evaluations:**

The student must have the preceptor complete a student evaluation by week seven and/or week 14 of the MSSU Clinical Partnership Program. The Adult Health IV course lead will provide access to the preceptor evaluation of the student, student evaluation of the preceptor, and clinical log of hours using the process of QR codes as described in the Preceptor Handbook policies/process.

**Clinical Agreement Form:**

The student will provide a Clinical Agreement form to the preceptor on the first clinical day. The completed form will be submitted to the BSN coordinator and the Adult Health IV course lead/clinical faculty before starting the NCPP. The student must submit a new Clinical Agreement form for any change in preceptor. The student should contact the Adult Health IV course lead and/or BSN Coordinator should a change in preceptor be required by the healthcare facility.
